Dear Member,

CLECAT members are invited to a webinar on **16 May (14:30 -16.00)** on the **European Freight Transport Information Regulation**.

The [eFTI Regulation](#) obliges EU Member States to accept regulatory transport information if a company wishes to provide it in a digital format. At the same time, the eFTI Regulation harmonises the data and the systems through which the data is exchanged across different countries, pieces of legislation and modes of transport. The [DTLF](#) supports and contributes to the development and implementation of the new eFTI regulation that will be mandatory for members states from 2025.

As CLECAT members are active in all stages of freight transport and logistics, it will be imperative to gain a better overview of how the eFTI will be operating and how it connects with existing legislation.

The main objective of the webinar is to create a common understanding of how to incorporate eFTI in business operations and how freight forwarders should plan for this. The content of the webinar will therefor relate to discussion points such as:

- When the regulation will be effective with implementing and delegation acts and what should industry and authorities prepare for.
- What the eFTI will mean for logistics service providers
- How to position eFTI for large companies and SMEs who have different digitalization maturity levels.

The webinar is open to all CLECAT members (and their national members).
