Possible inconsistencies in EOS/EORI

- ❑ Persons, established in the Union, registered by the customs authorities of a MS that is different from the MS where they are established
- ❑ No 'Postcode' in the EORI records
 - Legal obligation to provide 'Postcode' in:
 - D.E. 3 'Address of Establishment/Address of Residence'
 - D.E.7 'Contact Information'
- ❑ The same 'Postcode' ('generic' post code) registered in EORI records for multiple persons with different addresses of establishment/residence

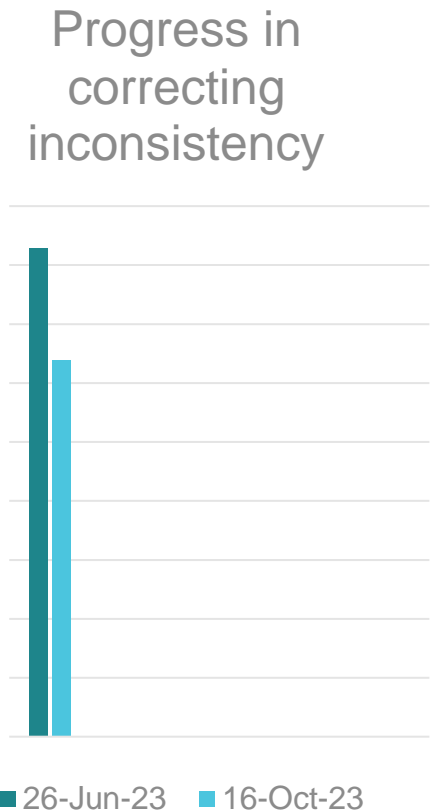

The number of EORI records of persons established in a MS but not registered by the customs authority of their MS of establishment

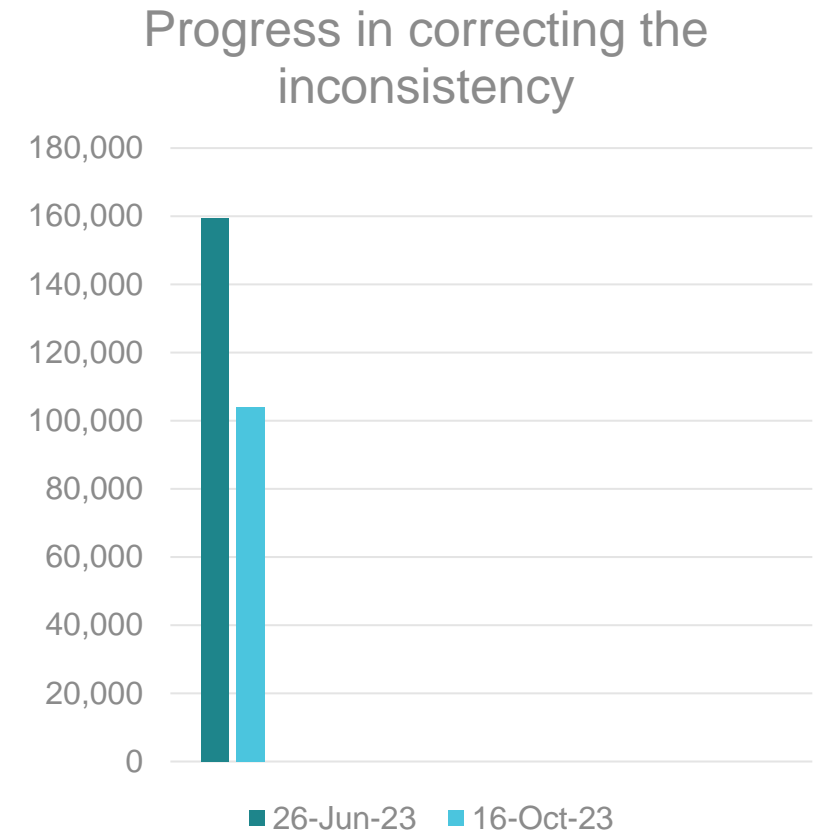

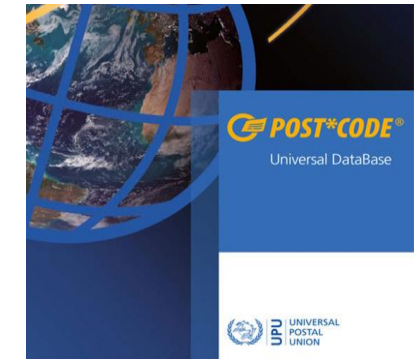


Number of economic persons registered by any MS and no postcode is registered in the address, on 16 October 2023

- Check possible inconsistencies
- If necessary, ask traders and other persons concerned to confirm/correct the accuracy of the data provided
- Correct existing registrations
- Ensure that new registrations are correct as required by applicable legislation
- Contact DG TAXUD in case further information or assistance is required via taxud-b1-dih@ec.europa.eu

Actions for TCG members

- Inform members about the possible inconsistencies
- Ask members to ensure that all data that are legally requested are submitted during the EORI registration
- Encourage economic operators to check the correctness of their registered data

Actions for TAXUD

- Regularly monitor the evolution of figures
- Provide information on changes to Member States via:
 - CEG/CCC DIH
 - ECCG
 - Teams

Actions planned for DG TAXUD

The entity **CL 505** will be updated, and it will **contain only the countries that**, according to the Universal Postal Union, **are not using the post codes**

Member States country codes will be invalidated in CL505

Without 'Postcode' information in EOS/EORI, validation will not be possible for the persons established in EU

Actions taken by TAXUD

- EOS Release 4.7.0.0 - to be delivered on **Q1 2024**
- Field 'Postcode' will be changed from "Optional" to "Required" in EOS/EORI for persons with an 'Address of establishment/address of residence' in a country (**MS or third country**) that use Post Codes

All the EORI address fields should respect the following:
The Annex A defines the cardinality of the following data elements of an address:

- Phone number M an..50
- Fax number O an..50
- Email address M an..256
- Street and number M an..70
- Postcode O[1] an..17
- City M an..35
- Country M a2

[1] As some countries in the world are not using postcodes, the cardinality of the element is set to 'Optional'.

Could you please check how this is implemented in AEO and EORI?

□ For the Post Code, we must verify the CSR2 Code List **CLS05** "CountryWithoutZip" to set it as mandatory or not depending on the Country that is set in the address.
IF /*...Address/country is in SET CLS05
THEN /*.../Address/postcode = "Optional"
ELSE /*.../Address/postcode = "Required";
