Dear Member,

Following a meeting between the Secretariat and the European Commission at the end of April, we have been invited to collaborate on the Global Gateway strategy as a key stakeholder to promote the initiative and share information to national associations and member companies interested in international cooperation and development in the area of transport and logistics. Several workshops will be organised by the Commission in the next weeks on

establishing rail corridors in Asia, Africa and Green Shipping Corridors across European trade lanes, where the Secretariat will take active participation. The Commission is organising hybrid workshops on transport & logistics in Central Asia, in Uzbekistan (22 May) and Kazakhstan (23 May), where companies operating in the region are invited to participate and potentially collaborate in various Global Gateway projects. Could you please share this invitation to your member companies operating in Central Asia which might be interested in participating in these workshops? National associations are also invited to attend these workshops. For reference, the Global Gateway initiative was launched in 2021 and aims to promote investments in third countries to tackle global challenges, from fighting climate change, to improving health systems, and boosting competitiveness and security of global supply chains. As transport and logistics is one of the key pillars of Global Gateway, the Commission is exploring opportunities for collaboration and investment in third countries' transport infrastructure, mostly in Africa and Asia.
